

# 8TH SESSION OF THE UNITED NATIONS FORUM ON BUSINESS AND HUMAN RIGHTS

November 24-27, 2019

## 1. What is the Forum?

Established in 2011, the three-day annual UN Forum on Business and Human Rights serves as a global platform for stakeholders, such as states, intergovernmental organizations, businesses, labor unions, national human rights institutions, non-governmental organizations, and affected right holders, to discuss trends and challenges in the implementation of the Guiding Principles on Business and Human Rights and to promote dialogue and cooperation on issues linked to business and human rights.

## 2. What does the Forum do?

Guided and chaired by the Working Group on Business and Human Rights (WG B&HR), as per the Human Rights Council resolutions 17/4 and 35/7, the Forum is the world's largest annual gathering on business and human rights. It gives the possibility to more than 2 000 stakeholders to network, share experiences and learn about the latest initiatives to promote corporate respect for human rights.

With the theme "Time to act: Governments as catalysts for business respect for human rights", the 2019 Forum will focus on the need for *all* governments to demonstrate progress, commitments and plans to implement the state duty of protecting and strengthening accountability. #### 3. How to participate in FBHR sessions

In 2019, due to ongoing construction work and consequent space constraints at the Palais des Nations in Geneva, participation will be capped at 2 000 participants, on a first-come, first-served basis. ## 4. Indigenous Peoples and the Forum

Since the Forum's first session, every year, thanks to the participation and advocacy efforts of Indigenous Peoples, there is a systematic inclusion of issues related to Indigenous Peoples' rights in the Forum reports, as well during the country visits by the Working Group.

- So far two reports have focused on Indigenous Peoples:
  - A/68/279: "Business-related impacts on the rights of Indigenous Peoples"
  - A/71/291: "Addressing the human rights impacts of agro-industrial operations on indigenous and local communities: State duties and responsibilities of business enterprises"

This Indigenous Caucus preparatory meeting represents a unique opportunity for indigenous delegates to meet, exchange information and experiences, as well as a chance to unify their voices for a better representation during the Forum.

- During their Caucus meeting, the indigenous delegates will:
  - put together joint statements, positions and recommendations;
  - discuss with the members of the UN WG B&HR;
  - benefit from a workshop on: "Guidance on ways to submit individual complaints procedures to the WG so that they can engage in discussions with the states".

- The participation of indigenous delegates to the Forum contributes to:
  - guiding the work of the Working Group when interpreting the Guiding Principles, in line with international standards on Indigenous Peoples' rights;
  - providing factual context for the implementation of the Guiding Principles;
  - enhancing the representation of and strengthening the link between Indigenous Peoples;
  - facilitating direct discussions with high-level decision makers and businesses.





## 5. Signing up to make a written statement

The Forum was established by the UN Human Rights Council "to discuss trends and challenges in the implementation of the Guiding Principles and promote dialogue and cooperation on issues linked to business and human rights", in the form of "interactive dialogue". This means that the Forum strongly encourages representatives not to read from written statements and to engage with participants in the different Forum sessions, including sessions' panelists. If you wish to actively participate in an interactive dialogue, you will simply need to raise your hand and wait for the chair to give you the floor.

Please note all stakeholders are invited to submit brief reports on relevant legal, regulatory and policy developments at global, regional or national levels. Submissions will be posted on the Forum Webpage.

## 6. Submitting complaints

Individuals or groups are invited by the Working Group to send information of alleged human rights abuses on the issue of human rights, transnational corporations and other business enterprises.

On the basis of such allegations, and where deemed appropriate, the Working Group will send a letter to states, business enterprises and others to draw their attention to the facts and to the applicable international human rights norms and standards, in particular the Guiding Principles on Business and Human Rights.

Communications sent and replies received are published in joint communications reports and submitted to each regular session of the Human Rights Council.

## 8. Badges and access to the Palais des Nations

All visitors must collect their badge upon arrival and enter the Palais des Nations via the Pregny Gate:

**Standard working hours:** Monday-Friday: 8 a.m. to 5 p.m. - During the Forum, registration is expected to be **open on Sunday 25th of November until 7pm.** 

In order to collect your Forum badge, you must bring: - Your passport and/or ID; - A copy of the confirmation of your registration (your "e-ticket").

Queues for registration are common and participants wait in the open air, therefore you are strongly advised to be at Pregny Gate one hour before the session starts.

Luggage: You may bring only small-sized luggage into the Palais des Nations (e.g. computer bags, rucksacks and handbags).
