Mandate: This four-day expert workshop was mandated by Human Rights Council resolution 48/11 of 8

October 2021 (paragraph 15).

Format:

The expert workshop will be held from 21 to 24 November 2022 and consist of 8 meetings of the duration of 3 hours each.

The expert workshop will include representatives from States, and representatives of Indigenous Peoples from the seven socio-cultural regions determined to give broad representation to the world's Indigenous Peoples: Africa; Asia; Central and South America, and the Caribbean; the Arctic; Central and Eastern Europe, Russian Federation, Central Asia and Transcaucasia; North America; the Pacific (7 representatives from States and 7 representatives of Indigenous Peoples).

The Expert Mechanism on the Rights of Indigenous Peoples, the Special Rapporteur on the rights of Indigenous Peoples and other relevant United Nations bodies will also contribute to the workshop.

The expert workshop will be open to the participation of representatives of States, national human rights institutions, and civil society.

During the workshop, the possible measures necessary to enhance participation of Indigenous Peoples in meetings of the Human Rights Council, including the procedural and institutional steps and selection criteria that should be applied for their participation will be discussed. To do so, the discussion will be structured according to the following four topics:

- 1) Venues of participation: under this heading participants will discuss the opportunity for Indigenous Peoples' representatives and institutions to participate in meetings of the Human Rights Council, including the interactive dialogue with the Special Rapporteur on the rights of Indigenous Peoples; sessions of the Expert Mechanism on the Rights of Indigenous Peoples; and annual half-day discussion, panels and intersessional activities on the rights of Indigenous Peoples.
- 2) Participation modalities: under this heading participants will assess the modalities under which Indigenous Peoples participate in other United Nations mechanisms, such as the Expert Mechanism on the rights of Indigenous Peoples and the Permanent Forum on Indigenous Issues, to see whether any aspects of those modalities could be applicable to the work of the Human Rights Council. This would include the right to speak at specific times, to make written submissions and adequate seating arrangements. The current participation modalities in, as well as the procedures and practices of the Human Rights Council within the existing Institution Building package, will also be considered.
- 3) **Selection mechanism**: under this heading participants will discuss the nature and composition of a body/mechanism that will determine the eligibility of Indigenous People's representatives and institutions for accreditation as well as the details of the process.
- 4) **Selection criteria**: under this heading participants will discuss the criteria for determining the eligibility of Indigenous Peoples' representatives and Institutions for accreditation as such; the type of Indigenous Peoples' institutions that may qualify for a new category of participation and the designation of individual representatives of Indigenous Peoples.

Interpretation will be provided in the six United Nations official languages (Arabic, Chinese, English, French, Russian and Spanish).

Background on the process:

Since the adoption of resolution 69/2 entitled Outcome document of the high-level plenary meeting of the General Assembly known as the World Conference on Indigenous Peoples, the General Assembly considered how to enable the participation of Indigenous Peoples' representatives and institutions at the United Nations. The General Assembly, in resolution 70/232 requested the President of the General Assembly to conduct consultations on this issue and prepare a compilation of the views expressed during the consultations which can be found in A/70/990. In 2017, the General Assembly adopted resolution 71/321 entitled Enhancing the Participation of Indigenous Peoples' Representatives and Institutions in Meetings of Relevant United Nations Bodies on Issues Affecting Them, which started a process on this issue that is ongoing.

The Human Rights Council adopted resolution 39/13 in which it decided to hold a half-day intersessional interactive dialogue and resolution 42/19 in which it decided to hold an intersessional round table on ways to enhance the participation of Indigenous Peoples' representatives and institutions in meetings of the Human Rights Council on issues affecting them. The summary reports of the half-day intersessional interactive dialogue and of the intersessional round table can be found respectively in A/HRC/44/35 and in A/HRC/49/69.
