## Access to remedies for business-related human rights abuses:

### **Workshop for Indigenous Caucus**

Individual and communities affected by business-related human rights abuses continue to face multiple barriers in seeking effective remedies and holding the relevant enterprises accountable for such abuses. During the 2018 pre-UN Forum dialogue with the Indigenous Caucus, the UN Working Group on Business and Human Rights felt that the Indigenous Caucus participants should benefit from a dedicated workshop exposing them to a range of remedial options.

The workshop will discuss mechanisms concerning complaints to (i) the National Contact Points under the OECD Guidelines for Multinational Enterprises, (ii) independent accountability mechanisms of international financial institutions such as the Compliance Advisor Ombudsman (CAO), and (iii) the UN Working Group on Business and Human Rights and other special procedures of the UN.

The objectives of the workshop are two-fold: first, to understand better the challenges and barriers faced by indigenous peoples in seeking access to remedies for business-related human rights abuses, and second, to raise awareness of affected members of the indigenous community about selected remedial options available to them.
